## 4. FIRST AID MEASURES

### GENERAL

### SPECIAL INSTRUCTIONS FOR FIRE FIGHTING PERSONNEL

Will not burn until all the water has evaporated. Cool closed containers exposed to fire with a water spray. Do not allow run off from fire fighting to enter drains or water courses.

## 6. ACCIDENTAL RELEASE MEASURES

Contain and collect spillages with non-combustible absorbent materials e.g. sand, earth and place in suitable container for disposal in accordance with the waste regulations. Clean preferably with a detergent, avoid use of solvents.

## 7. STORAGE & HANDLING

### Storage

Observe the label precautions. Store between 5 & 25°C in a dry well ventilated place away from sources of heat, ignition and direct sunlight. No smoking. Prevent unauthorised access. Containers which are opened should be properly resealed and kept upright to prevent leakage. Store away from oxidising agents and strongly alkaline or acid materials.

### Handling

Avoid skin & eye contact. For personal protection see Sect.8. Good housekeeping, regular maintenance of spray booth filters, and regular removal of waste materials will minimise risks.

## 8. EXPOSURE CONTROLS / PERSONAL PROTECTION

#### **Engineering Measures**
